Don Betz, Ph.D.

University of Central Oklahoma President Don Betz, Ph.D., has enjoyed a distinguished career in higher education that spans more than 46 years, developing a reputation for teaching and encouraging students, and leadership development. He is also known for his diplomacy skills, developed through his international activities, most notably with the United Nations and its affiliated non-government organizations.

Enhancing that reputation, he currently is serving on the International Association of University Presidents (IAUP) executive committee and as chair of its American Council. President Betz was selected to attend the 2011 Fulbright-Hays Seminar for Presidents Scholar, held in Oman and Jordan. The purpose was to explore opportunities for future program development in the region with stakeholders on American college campuses. Most recently, he was selected as a 2013 inductee of the Oklahoma Higher Education Hall of Fame and received the 2012 Governor's Arts Award from the Oklahoma Arts Council in recognition of his support and advancement of the arts throughout his career.

President Betz took his post as Central's 20th leader in August 2011. He previously served as Central's provost and vice president of Academic Affairs from 1999-2005, during which he developed several initiatives and programs that helped transform Central into a leading metropolitan university.

He served as a member of the founding implementation committee for the American Association of State Colleges and Universities (AASCU) American Democracy Project and is the past chair of Creative Oklahoma Inc., and Oklahoma A+ Schools. He is also a member of the Oklahoma Academy, Leadership Oklahoma, and the Universities and Colleges President's Climate Commitment. He serves on the boards for the United Way of Central Oklahoma, the Oklahoma City Boathouse Foundation, Oklahoma City Chamber of Commerce, Oklahoma State Chamber of Commerce, Oklahoma Center for the Advancement of Science & Technology (OCAST), Great Expectations, the DaVinci Institute, and the Edmond Economic Development Authority.

Prior to returning to Central, he served as president of Northeastern State University in Tahlequah, Okla., from 2005-2008. He served as chancellor at the University of Wisconsin-River Falls from 2005 until his appointment at Northeastern, and as provost and vice president for Academic Affairs at Palmer College, Davenport, Iowa, from 1994-1999. In the 23 years prior, he fulfilled various capacities at Northeastern, including the vice president of University Relations, professor of political science, as well as the executive director of the Educational Foundation and assistant to the president.

President Betz has also dedicated himself to advancing international relations, with a focus on the Middle East. From 1982 through 2003, he worked for and with the United Nations on Middle East issues. He founded and chaired the International Coordinating Committee on the Question of Palestine (ICCP), a U.N.-affiliated non-governmental organization (NGO) network pursuing peace in the Middle East based on U.N. resolutions. His international experience includes service with the University of Pittsburgh's Semester at Sea, Chapman College's World Campus Afloat, and journalistic experience in the Middle East.

A frequent writer and speaker, President Betz has addressed international, educational and motivational topics, and has worked with newspapers, radio and television. His lifelong interest in global issues and his passion for promoting cross-cultural understanding has led him to more than 80 countries.

President Betz holds a Bachelor of Arts in Political Science and Philosophy from the University of San Francisco as well as a master's degree and a Ph.D. in International Studies from the Korbel School of International Studies at the University of Denver.
