



INTERNATIONAL ASSOCIATION OF UNIVERSITY PRESIDENTS (IAUP) STUDENT EXCHANGE BANK CALL FOR PARTICIPATION

The IAUP is a UK based Charity Organization which aims at, among other things, increasing the exchange of experiences and collaboration networks between university leaders, contributing to a global vision of higher education, strengthening the international mission of its institutions, and providing a well-informed forum for its members throughout the world.

Recognizing the value of fostering global understanding and peaceful cooperation in an increasingly interdependent and rapidly changing world, IAUP is committed to developing international dimensions as an integral part of collegiate education, and striving for a high level of academic excellence, IAUP promotes and facilitates the exchange of students and faculty, through The IAUP Student Exchange Bank.

A limited number of participants will receive some financial support from IAUP on a first-come, first-serve basis.

STUDENT SELECTION

No bilateral agreement is required to participate in this initiative. In a given academic year, each Home Institution (HM) may send as many participants as the number of spaces they offered to build up this exchange bank.

Each Student will be counted as one when attending part of, or an entire academic term, or as two if attending the Host Institution (HS) for an entire Academic Year. Students cannot stay at the HS longer than one Academic Year.

IAUP serves as the liaison entity to facilitate the participation of the students. Once received, the application form will be redirected from IAUP to the officers of the HS selected by the student and the process then enters the stage validation by both the HM and the HS.

Starting with this Call for Participation, the HM may ask students to fill out the application form available at https://www.iaup.org/global-mobility/applicationform/. Here the student may choose the HS he would like to attend as well as the term: Fall 2023, Spring 2024, or Summer 2024.

Upon reviewing the information provided by the HS and available at the following link https://www.iaup.org/host-universities-global-mobility/, the HM shall advise students to send their application considering the deadlines proposed by the HS of their choice. That being said, HM and HS officers may, if necessary, reach an alternative agreement informing IAUP office about this.

Students must meet the following criteria:

- Students must be registered in a program of study at the HM.
- Students must have an above-average academic performance record at the HM.
- Students must meet the language proficiency requirements of the HS.
- Students' proposed programme of studies at the HS must be approved by both the HM and HS.

The HS reserves the right to make any final determination on the admissibility of each Student.

FEES AND FINANCIAL MATTERS

Host institutions will waive tuition and fees. However, Students are expected to have sufficient personal funds to cover any and all expenses not covered by the HM or the HS. Expenses which the Student must cover include, but are not limited to:

- Cost of living (including rent, food, and health care costs).
- Recreation.
- Travel and transportation, including travel insurance.
- Textbooks and school supplies; and
- Costs associated with any necessary immigration documents.

MISCELLANEOUS

The HS shall provide the Student(s) with a letter or transcript of his or her academic record as soon as possible after the completion of their participating term.

The HS agrees to provide general information to assist the Student in locating/obtaining housing.

Students will be bound by the rules, regulations, and codes of conduct of the HS and the laws of the host country.

The HS agrees to provide Students with letters of admission or other documents as these may be required for the Students to establish their status for immigration purposes. Students shall be responsible for complying with immigration legislation of the country of the HS. The HS shall cooperate in such efforts but shall not have any responsibility to assure the granting of visas, permits or approvals.

The HI agrees that adequate reception, orientation, and ongoing advice and support are available for Exchange Students.
